

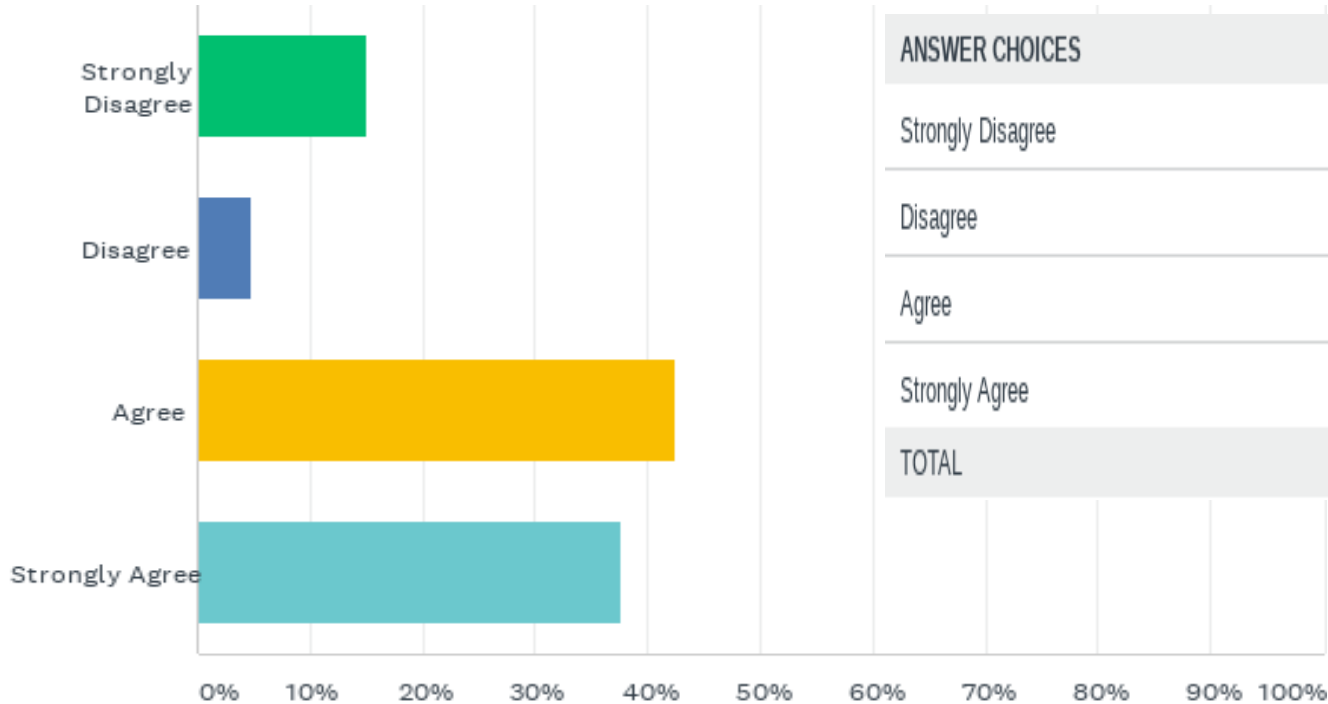

Q1: The public service announcements regarding COVID-19 assist me in better understanding how to protect myself and others against the virus.

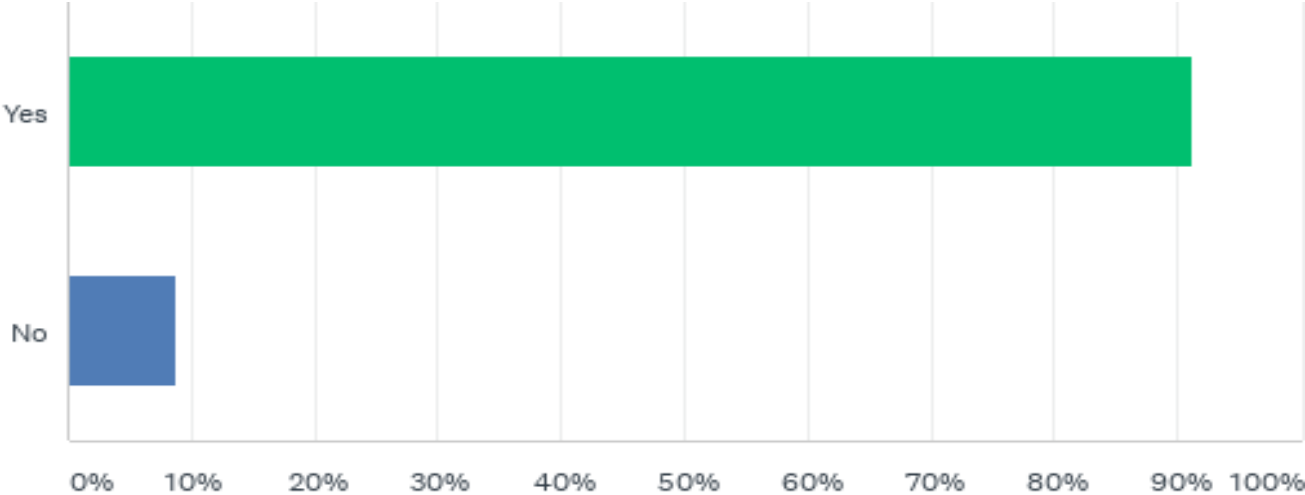

Q2: I would like the public service updates regarding COVID-19 to continue.

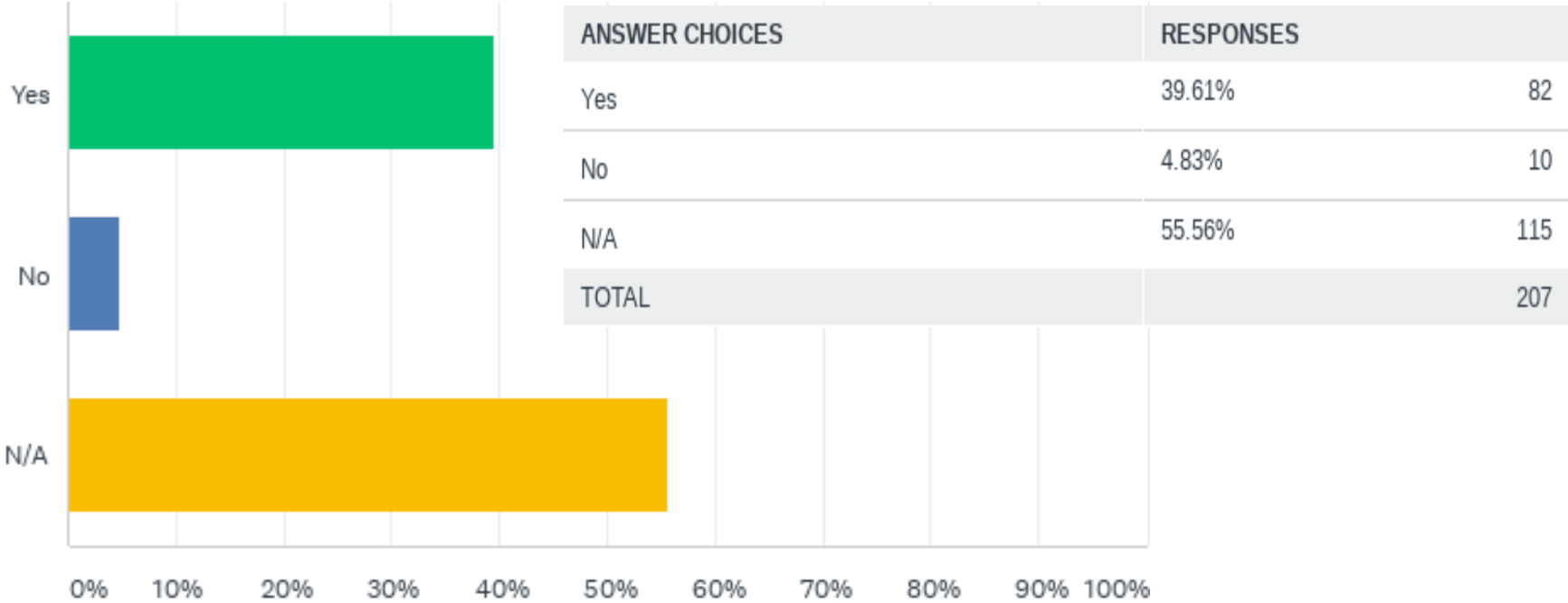

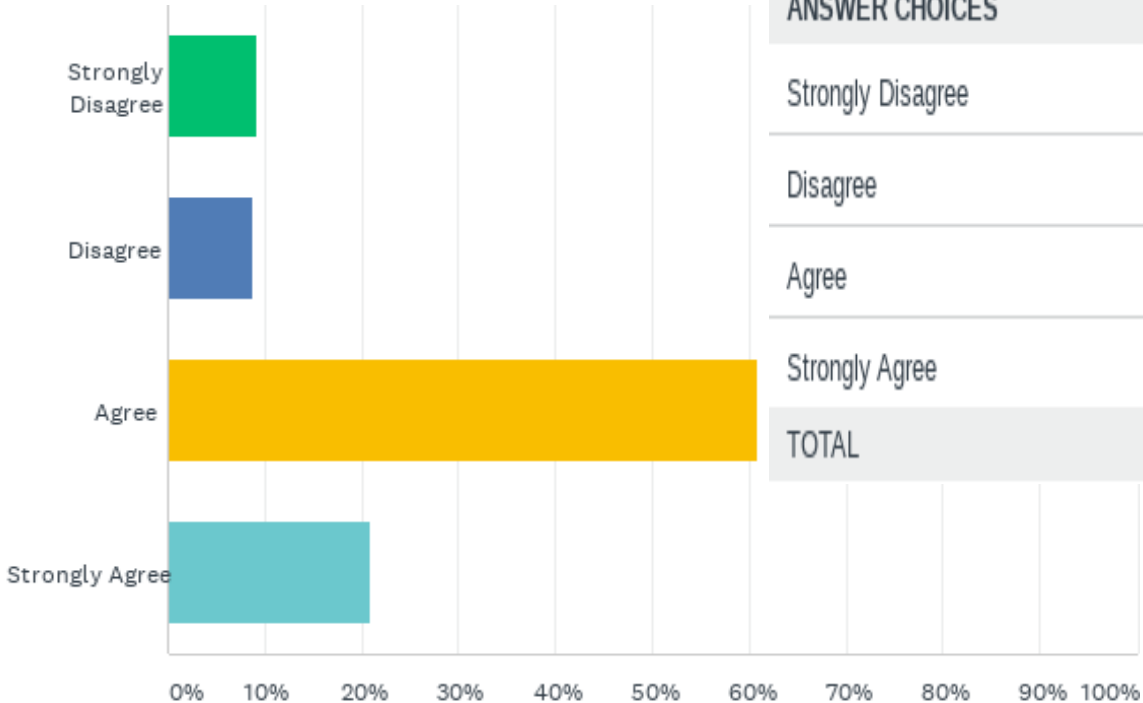
Q3: Did you gain a greater understanding about the safety and efficacy of the Covid-19 vaccine from the panel discussion held on MLK Day, January 18?

Q4: The updates on the incidence of COVID-19 in Chester County and the surrounding areas on the St. Paul's website help me to better understand the local impact of the virus.

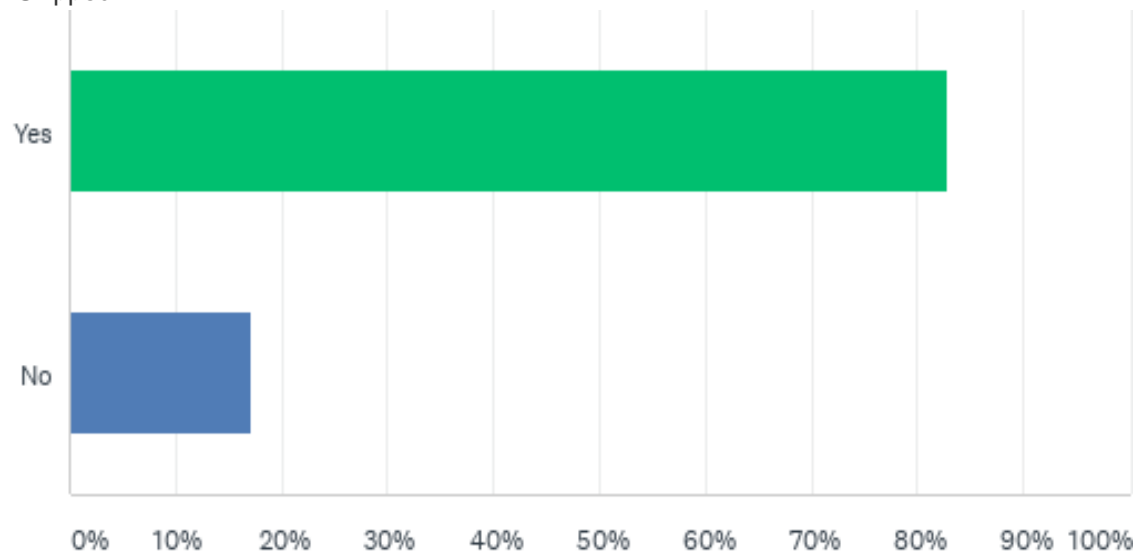

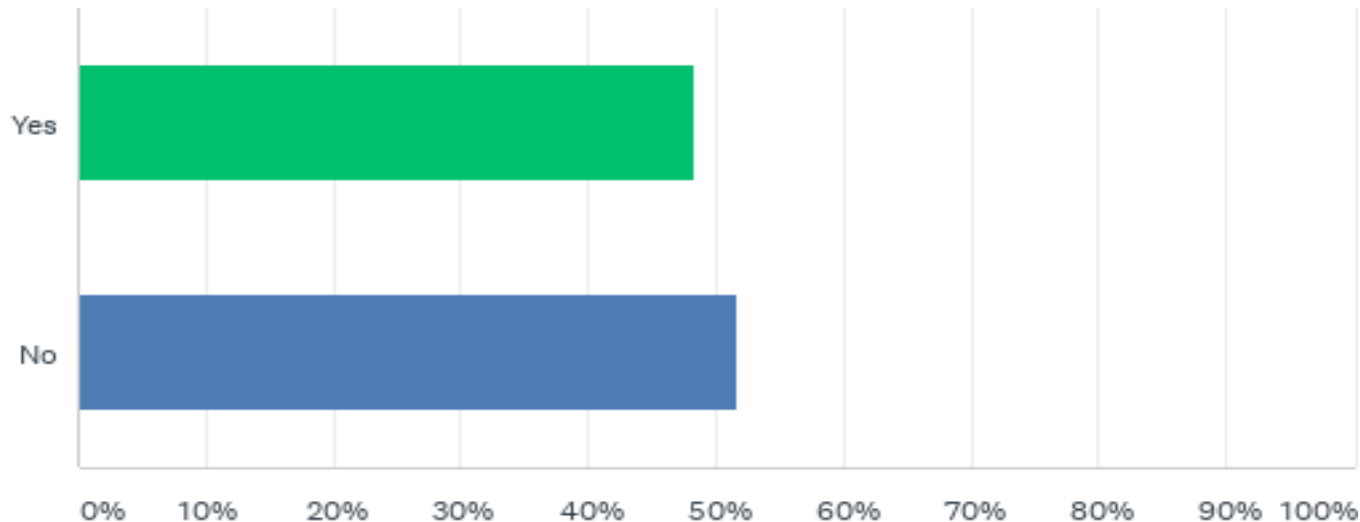
Q6: Are there three other COVID-19 topics you would like the Relaunch Taskforce to share with the congregation?

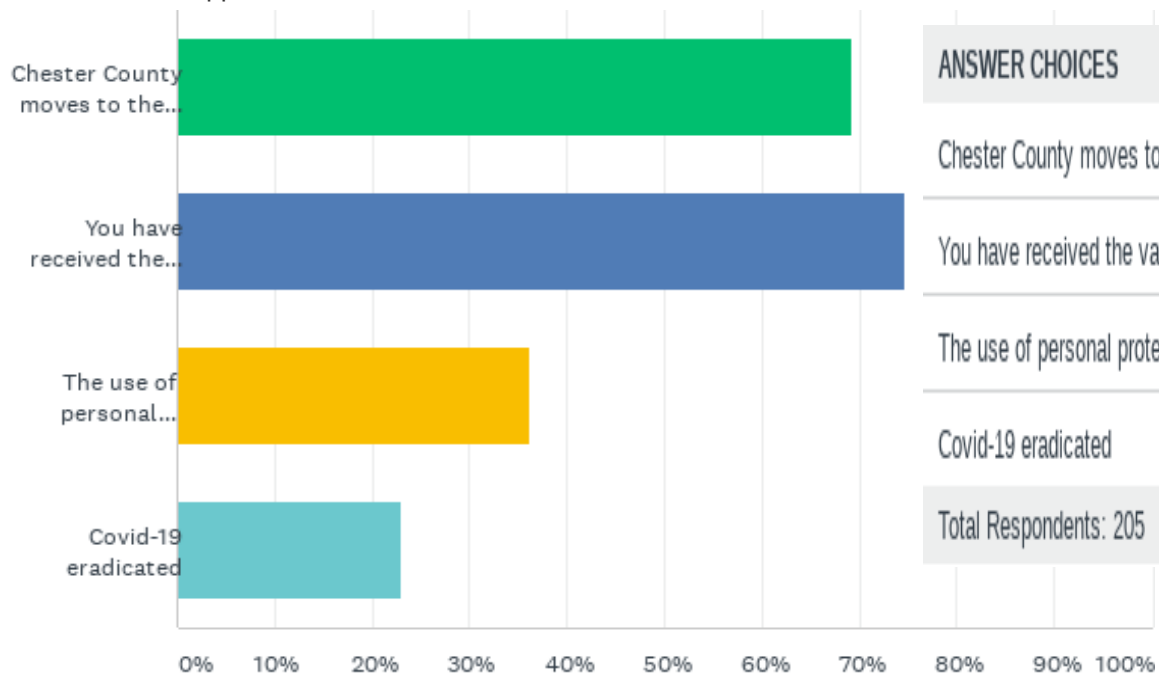
